In the consolidated financial statements of Hanoi Textile and Garment Joint Stock Corporation, there are:

Business results for the first 6 months of 2025:

- Profit after tax for the first 6 months of 2024: (83,396,300,023) VND
- Profit after tax for the first 6 months of 2025: 5,618,126,164 VND

The net profit after tax in the Consolidated Financial Statements for the first six months of 2025, which has been reviewed, changed by more than 10% compared to the first six months of 2024, and shifted from a loss in the same period of the previous year to a profit in the current period. Hanoi Textile and Garment Joint Stock Corporation would like to explain the reasons as follows:

The profit after tax for the first six months of 2025 of the Corporation increased compared to the same period last year, mainly due to the strong recovery of the market. The garment sector had sufficient orders and higher productivity, resulting in better performance compared to the same period of the previous year. Although the yarn sector still faced difficulties, the Corporation closely monitored the market and, at many points, was able to secure favorable cotton and yarn prices. In addition, Hanosimex Knitting Joint Stock Company (a subsidiary) shifted from fabric production to leasing factory premises. Thanks to these factors, the overall performance of the entire sector improved significantly compared to the same period last year.
