Pursuant to Decision No. 90/QĐ-HĐTV dated September 23, 2025 of the Members' Council of the Corporation on the promulgation of the Regulations on management of authorized representatives in respect of contributed capital (capital representatives) and personnel participating in the Supervisory Board at enterprises in which the Corporation has capital contributions.

Pursuant to Resolution No. 141/NQ-HĐTV dated December 31, 2025 of the Members' Council of the Corporation on the adjustment of the number of shares held by the Corporation's capital representative at Saigon Plant Protection Joint Stock Company.

DECISION

Article 1: To adjust the contributed capital portion of the Corporation's capital representative at Saigon Plant Protection Joint Stock Company, Mr. Vo Anh Tung, from 3,088,449 shares (equivalent to VND 30,884,490,000),

representing 29.33% of the Company's charter capital, to 3,088,020 shares (equivalent to VND 30,880,200,000), representing 29.33% of the Company's charter capital.

Article 2: Members of the Members' Council, the General Director, Deputy General Directors, the Chief of Office, Directors of the Corporation's specialized departments; heads of relevant units, and the Corporation's capital representative at Saigon Plant Protection Joint Stock Company shall be responsible for the implementation of this Decision./*Tr*
