- h. Borrowing from credit institutions and financial institutions domestically and internationally in accordance with applicable laws.
- i. Opening accounts: maintaining deposit accounts at the SBV with required reserve balances; branches maintaining accounts at SBV branches; opening payment accounts at other credit institutions and foreign bank branches; opening offshore deposit and payment accounts in accordance with foreign exchange regulations.
- j. Organizing and participating in payment systems: internal payment systems, the national interbank payment system, and international payment systems subject to SBV approval.
- k. Participating in the money market: bidding for Treasury bills; trading negotiable instruments, government bonds, treasury bills, SBV bills, and other valuable papers.
- l. Foreign exchange and derivatives business: providing foreign exchange and derivatives products (including interest rate, currency, and other financial derivatives) upon SBV approval.
- m. Entrustment and agency activities in banking, insurance business, and asset management in accordance with SBV regulations.
- n. Real estate business: not permitted except for specific cases such as owning property for operational use, leasing unused office space, or holding real estate from debt recovery, subject to regulatory limits.
- o. Other business activities: cash management, money brokerage, financial advisory, asset custody, safe deposit services, corporate finance advisory, M&A advisory, investment advisory, trading government and corporate bonds, and debt trading in accordance with applicable laws.
