HEREBY DECIDES:

Article 1. To amend the License for establishment and operation No. 125/GP-UBCK dated May 30, 2018 issued by the Chairman of the State Securities Commission to Techcom Securities Joint Stock Company with the following contents:

Charter capital: VND 27,738,968,030,000 (In words: Twenty-seven thousand seven hundred and thirty-eight billion nine hundred and sixty-eight million zero hundred and thirty thousand Vietnamese dong)

Article 2. This License shall take effect from the date of signing and is an integral part of the License for establishment and operation No. 125/GP-UBCK dated May 30, 2018 issued by the Chairman of the State Securities Commission to Techcom Securities Joint Stock Company.
