*Pursuant to the Law on Securities dated November 26, 2019 and the Law amending and supplementing a number of articles of the Law on Securities, the Law on Accounting, the Law on Independent Audit, the Law on the State Budget, the Law on Management and Use of Public Assets, the Law on Tax Administration, the Law on Personal Income Tax, the Law on National Reserves, Law on Handling of Administrative Violations dated November 29, 2024;*

*Pursuant to the Government's Decree No. 155/2020/NĐ-CP dated December 31, 2020, detailing the implementation of a number of articles of the Securities Law and the Government's Decree No. 245/2025/NĐ-CP dated September 11, 2025, amending and supplementing a number of articles of Decree No. 155/2020/NĐ-CP;*

*Pursuant to Decision No. 02/QĐ-HĐTV dated June 30, 2021, of the Members' Council of the Vietnam Stock Exchange on the establishment of the Ho Chi Minh Stock Exchange;*

*Pursuant to Decision No. 07/QĐ-HĐTV dated July 09, 2021 of the Members' Council of the Vietnam Stock Exchange promulgating the Charter of organization and operation of the Ho Chi Minh Stock Exchange;*

*Pursuant to Decision No. 22/QĐ-HĐTV dated March 16, 2026 of the Members' Council of the Vietnam Stock Exchange on the promulgation of the Regulations on listing and trading of listed securities;*

*Pursuant to the application dossier for amendment to the listing registration of Techcom Securities Joint Stock Company;*

**DECISION:**

**Article 1.** Approval of the amendment to the listing registration of Techcom Securities Joint Stock Company with the following details:

- Type of securities: Common shares
- Securities code: TCX
- Par value: VND 10,000 per share
- Number of listed securities before the amendment: 2,311,583,496 shares (*In words: Two billion three hundred eleven million five hundred eighty-three thousand four hundred ninety-six shares*)

- Additional listed securities: 462,313,307 shares (*In words: Four hundred sixty-two million three hundred thirteen thousand three hundred seven shares*)
- Value of additional listed securities (at par value): VND 4,623,133,070,000 (*In words: Four trillion six hundred twenty-three billion one hundred thirty-three million seventy thousand dong*)
