DECISION

On the Imposition of Administrative Penalties for Tax Violations

DIRECTOR OF HO CHI MINH CITY TAX DEPARTMENT

Pursuant to Articles 57, 68, 70, 78 and 85 of the Law on Handling of Administrative Violations (as amended and supplemented in 2020 and 2025);

Pursuant to the Law on Tax Administration dated December 10, 2025 and the guiding documents for its implementation;

Pursuant to the tax laws and the guiding documents for their implementation;

Pursuant to Decree No. 310/2025/ND-CP dated December 02, 2025 of the Government amending and supplementing a number of articles of Decree No. 125/2020/ND-CP dated October 19, 2020 of the Government on administrative penalties for tax, invoice violations;

Pursuant to Decree No. 125/2020/ND-CP dated October 19, 2020 of the Government on administrative penalties for tax and invoice violations; Decree No. 102/2021/ND-CP dated November 16, 2021 of the Government amending and supplementing a number of decrees on administrative penalties in the fields of taxation, invoices, customs, insurance business, lottery business, management and use of public assets, thrift practice and waste prevention, national reserves, state treasury, accounting, independent auditing;

Pursuant to Decision No. 1376/QD-CT dated June 30, 2025 of the Director General of the Tax Department prescribing the functions, duties, powers, and organizational structure of the provincial and municipal Tax Departments under the Tax Department;

Pursuant to Decision No. 3736/QD-CT dated December 31, 2025 of the Tax Department prescribing the functions, duties and powers of the Office and the Divisions under the Provincial and Municipal Tax Departments;

Pursuant to Decision No. 910/QD-TPHCM dated February 02, 2026 of the Director of Ho Chi Minh City Tax Department on the assignment of areas of responsibility and units under the management of the leadership of Ho Chi Minh City Tax Department;

Pursuant to Decision No. 919/QD-TPHCM dated February 02, 2026 of the Director of Ho Chi Minh City Tax Department on the delegation of authority to impose administrative penalties;

Pursuant to Administrative Tax Violation Record No. 2688/BB-VPHC, prepared by officer Nguyen Le Ngoc Dung on June 11, 2026 at Ho Chi Minh City Tax Department;

At the proposal of the Head of Enterprise Management and Support Division No. 2,

HEREBY DECIDES:

Article 1. To impose administrative penalties upon the following organization:

1. SAI GON VIEN DONG TECHNOLOGY JOINT STOCK COMPANY

Head Office: 102A Pho Co Dieu Street, Minh Phung Ward, Ho Chi Minh City.

2. The organization has committed administrative violations of tax procedures as prescribed under the Law on Tax Administration, specifically by filing the following tax declaration beyond the statutory deadline:

3. Administrative violation subject to penalties:

The taxpayer committed an administrative violation subject to penalties under Clause 5, Article 13 of Decree No. 125/2020/ND-CP dated October 19, 2020 of the Government on administrative penalties for tax and invoice violations.

4. Aggravating and mitigating circumstances:

a) Mitigating circumstances: None.

b) Aggravating circumstances: None.

5. Other circumstances relevant to the resolution of the violation (if any): None.

6. The following forms of penalties and remedial measures shall be imposed:

a) Principal penalty:

Total fine: VND 20,000,000 (In words: Twenty million Vietnam Dong), including:

- A monetary fine for the late submission of the Personal Income Tax Withholding Return, Form No. 05/KK-TNCN, Quarter 2/2025, beyond the prescribed deadline. Fine amount according to Sub-item 4268: VND 20,000,000 (In words: Twenty million Vietnam Dong).

b) Additional penalty (if any): None.

c) Remedial measure:

The taxpayer shall pay any late payment interest on the tax amount in accordance with the Law on Tax Administration and the documents detailing the implementation of such Law (if applicable).

Article 2. This Decision shall take effect from the date of signing.

Article 3. This Decision shall be:

1. Served upon Ms. Pham Thi Nhu Ngoc, the legal representative of the violating organization specified in Article 1 of this Decision, for implementation.

Within ten (10) days from the date of receipt of this Decision, the organization specified in Article 1 must strictly comply with this penalty decision. The fine specified in Article 1 shall be paid into Account No. 7111.1056137 of the Ho Chi Minh City Tax Department, maintained at the State Treasury – Region II, address: No. 37 Nguyen Hue Street, Sai Gon Ward, Ho Chi Minh City.

If, after the above-mentioned time limit, SAI GON VIEN DONG TECHNOLOGY JOINT STOCK COMPANY fails to comply with this penalty decision, compulsory enforcement of the administrative decision shall be carried out in accordance with the law.

The organization specified in Article 1 shall have the right to lodge a complaint or initiate legal proceedings against this Decision in accordance with the provisions of law.

2. Sent to the State Treasury – Region II for collection of the fine.

3. Sent to Enterprise Management and Support Division No. 2 for implementation of this Decision.
