Pursuant to the Charter on organization and operation of Bank for Investment and Development of Vietnam JSC (BIDV);

Pursuant to Circular No. 61/2025/TT-NHNN dated 31/12/2025 of the Governor of the State Bank of Vietnam promulgating Regulations on the operational network of commercial banks;

Pursuant to Decision No. 663/QĐ-BIDV dated 11/6/2025 of BIDV's Board of Directors on decentralization of authority in business plan management and network;

Pursuant to Regulation No. 1245/QyĐ-BIDV dated 13/02/2026 of BIDV's General Director on BIDV's network operations;

DECIDES:

Article 1. To change the headquarters location of Bank for Investment and Development of Vietnam JSC - Bac Ha Branch as follows:

- Current location: Company office building 789, No. 147 Hoang Quoc Viet Street, Nghia Do Ward, Hanoi City.

- New location: Han Jardin Building, Lot NO1-T6, T7 Doan Ngoai Giao Area, Hoang Minh Thao Street, Xuan Dinh Ward, Hanoi City.

- Operation time at the new location: expected from 14/09/2026.
