DECISION

Re: Relocating the head office of Thu Thiem Branch under the Joint Stock Commercial Bank for Investment and Development of Vietnam

Based on the Charter on the Organization and Operation of the Joint Stock Commercial Bank for Investment and Development of Vietnam (BIDV);

Based on Circular No. 61/2025/TT-NHNN dated December 31, 2025 of the Governor of the State Bank of Vietnam promulgating the Regulations on the operating network of commercial banks, as amended by Circular No. 11/2026/TT-NHNN dated May 19, 2026.

Based on Decision No. 663/QĐ-BIDV dated June 11, 2025, of the BIDV Board of Directors regarding the delegation of authority in business plan and network management;

Based on Regulation No. 1245/QyĐ-BIDV dated February 12, 2026 issued by the BIDV General Director on BIDV's network operations, and the applicable amendments and guidelines thereto.

Based on Official Letter No. 7755/KV2-GS1 dated August 21, 2026 of the State Bank of Vietnam – Region 2 Branch regarding the approval of the change of the head office location of BIDV – Thu Thiem Branch.

As per the proposal of the Director of the Planning Department.

DECISION:

Article 1. Relocating the head office of the Joint Stock Commercial Bank for Investment and Development of Vietnam – Thu Thiem Branch as follows:

- Former Location: Ground Floor, Mezzanine Floor, 1st Floor, 2nd Floor and 3rd Floor, No. 33–33A Tran Nao Street, An Khanh Ward, Ho Chi Minh City.
- New Location: Office No. 1.12B (1.14), Office No. 1.15 on the 1st and 2nd Floors, and Office No. 3.03 on the 3rd Floor, Tower C, The Crest Residence Building, Lot 1-13, No. 15 Tran Bach Dang Street, An Khanh Ward, Ho Chi Minh City.
- The operational time at the new location: expected to begin from October 5, 2026.

Article 2. Thu Thiem Branch is responsible for completing the legal procedures for the branch name change, branch location change and ensuring the disclosure of information in compliance with the regulations of the law and the Joint Stock Commercial Bank for Investment and Development of Vietnam.

Article 3. This decision shall take effect from the date of signing.

Article 4. The Director of Planning Department, Directors of Departments/Centers at the Headquarters of the Joint Stock Commercial Bank for Investment and Development of Vietnam, the Director of Thu Thiem Branch are responsible for implementing this decision.
