Subject	Remove stock from warning status

Content:

On September 23, 2026, the Hochiminh Stock Exchange issued Decision No. 722/QD-SGDHCM to remove the DQC shares of Dien Quang Group Joint Stock Company from the warning status as of September 25, 2026.

Reason: The undistributed profit after tax as of June 30, 2026 was VND 129.7 billion, and the auditor expressed an unqualified opinion according to the reviewed semi-annual consolidated financial statements for 2026. This is the case of securities to be removed from warning status under Point b, Clause 4, Article 40 of the Rules of listing and trading of listed securities promulgated with Decision No.22/QD-HDTV dated March 16, 2026 by the Members' Council of the Vietnam Stock Exchange.
