DECISION

Article 4. Members of the Board of Directors, Personnel Committee, Board of Executives, Directors of Divisions, the Regional Directors, the Representative Office Directors, the Heads of Departments, the Head Office Center Directors, Branches, Transaction Offices, all officers, employees, and units under Kien Long Commercial Joint Stock Bank; the individual named in Article 3, and Ms. Vu Ngoc Lan Chau are responsible for executing this Decision.

Article 5. This Decision takes effect from the date of signing.
